THE REVISED RATE SCHEDULE & OTHER CONDITIONS FOR HIRING OF FORKLIFTS EFFECTIVE FROM 1st April - 2013

1. CHARGES : SHIFT - WISE

When a Forklift engaged Shift-Wise the charges shall be as per Schedule below.

2. SHIFT TIMINGS :

Port Trust Shift timings shall be observed in the Docks as well as in Greater Mumbai and Thane. No work shall be done during lunch break unless additional Payment is agreed on proreta basis.

3. GARAGE TO GARAGE CHARGES :

(a) The hire shall be charged from the time forklift leaves our depot till the time it returns to Garage.

(b) The time taken by forklift to return to the depot shall be charged extra as under :

From Upto Colaba, Sewree, Byculla Minimum ½ Shift

From Upto Sion, Mahim, Wadala, Worli, Walkeshwar ½ Shift

From Upto Ghatkopar, Kurla, Bandra, Santacruz

Andheri Chembur & Mankhurd..... One Shift

From Upto Borivali, Mulund, Bhandup, Goregaon and up to Dahisar One Shift

From Upto Thane, Navi Mumbai & (Vashi)One Shift.

4. MINIMUM CHARGES :

(a) Minimum Charges for ½ Shift i.e. only in 1st Shift.

(b) II nd Shift and III rd Shift Minimum Charges 1 Shift.

(c) Forklift Working on Board will be Charged for Full shift only.

(d) Forklift working beyond Kurla & Bandra shall be charged minimum for Two Shift.

5. SUNDAYS & HOLIDAYS :

No job shall be undertaken for less than a shift on sundays and Holidays. Holiday means Mumbai Port Trust Holiday

6. BOOKING CANCELLED :

The Booking of Forklift if cancelled, the minimum 2 hours charged to be paid as per Forklift capacity booked.

7. CUSTOMER'S RESPONSIBILITY :

Forklift Shall be supplied purely as per the order of the Customer's obligation to see that nothing more is lifted then the indented capacity. If this is violated the entire reparability for the damages to the Forklift and crew and third party

8. The Forklift shall be supplied at Hirer's risk only. The Forklift Owner shall be not be liable for any damages or loss during the loading and unloading operations.

2nd Shift : 6.00 P.M. to 11.30 P.M. (8.00 to 8.30 Dinner)

3rd Shift : 1.00 A.M. to 5.00 P.M. (3.00 to 3.30 Tea)
