- 1.2 Bidders not meeting the above requirements shall be rejected. Pre-qualification of the bidders shall not imply final acceptance of the tender. 2.0 Delivery

- 2.1 **The jeweler would be required to deliver the Gold Coins at Kolkata, Delhi, Mumbai and Chennai Offices of the Company.**

- 2.2 **The delivery shall be required to be made within fifteen days from the date of placement of order.**

3.0 Price rejection for delayed delivery
