However, submission of EMD would be exempted for Small Scale Units registered with National Small Industries Corporation (NSIC) & Micro, Small and Medium Enterprises (MSME) on submission, of valid copy of registration certificate. The physical original instruments/drafts should reach our above address prior to due date and time. #### 1. Filling of Tender Documents

## SCOPE OF WORK

Work covered in this tender document shall generally be as detailed herein below. However, contractor shall be responsible to complete the work in all respects and in doing so provide/supply all facilities which may not be covered explicitly herein below but nevertheless are required to complete the work envisaged with the exception of only such items as have been specifically excluded from vendor's scope.

The successful tenderer shall have to undertake the following work:

#### **Detailed Scope of work:**

# Comprehensive Annual Maintenance of 80 MT capacity weigh bridge. The scope of work covers the following:

- a) During the AMC period, the service engineer has to visit our premises four times at a frequency of one visit in each quarter for carrying out preventive maintenance of weighbridge. Out of which one visit will be for overhauling and preparation of weighbridge for re-verification by Govt inspectors in accordance with Weights and Measures Act.
- b) Coordinating and Liasoning with Government authorities for getting the stamping done
- c) In addition to the above quarterly visits, the engineer have to attend all break-down calls on need basis
- d) Weigh bridge electronic components like Load cells, PCB in digitizer, junction box are covered in the scope of AMC and would be replaced at free of cost.
- e) Stamping fee and related expenses are to be covered in AMC.
- Note: Necessary Standard test weights for carrying out the annual calibration test for weighbridge would be provided by us.

## **GENERAL TERMS AND CONDITIONS**

#### 1. Experience criteria

- a) The bidder should have 2 years experience in Annual maintenance of weighbridge ending 31<sup>st</sup> March 2017 (Please attach proof of purchase orders)
- b) Payment of EMD of Rs.3,000/-
- c) Should not have been blacklisted by any PSU / Govt. Department (a self-certification is required and should be attached)

#### 2. Submission Of Bids

#### 3. Tender Opening

Bid will be opened as per due date mentioned in the Tender.

#### 4. Acceptance of offers

- 4.1 Balmer Lawrie reserves the right to accept any tender in whole or in part or reject any tender or all tenders or place order for any quantity, less than or more than the tendered quantity, without assigning any reason thereof.
- 4.2 Bids of any tenderer may be rejected if a conflict of interest is detected between the bidders and Balmer Lawrie at any stage.
- 4.3 The overall L1 status will be determined by looking at the total value quoted by the bidder.
- 4.4 Balmer Lawrie is not bound to accept the lowest rate for any tender. Balmer Lawrie also reserves its right to allow Public Enterprises (Central / State) price / purchase / contract / service preference as admissible under the existing Government policy. The decision of Balmer Lawrie in this connection will be final.
- 4.5 Incomplete tenders, conditional tenders, tenders received late or tender not conforming to the terms and conditions mentioned in the Tender documents or not accompanied by the requisite Earnest Money Deposit (unless exempted under the terms of this Tender) will be rejected.

#### 5. Negotiations

- 5.1 Balmer Lawrie reserves the right to negotiate with the Tenderer. Tenderer will have to attend the concerned office of Balmer Lawrie for negotiations/clarifications required from them, in respect of their quotations, without any commitment on the part of Balmer Lawrie.
- 5.2 In case of negotiation, the Tenderer should send the confirmation of outcome of such negotiation in writing so as to reach the concerned office of Balmer Lawrie within 3 days from the date of negotiation/ the time stipulated whichever is earlier. If the Tenderer fails to comply with this requirement Balmer Lawrie reserves its right to ignore their quotation at its discretion with the attendant remedies available to them.

#### 6. Price Variation

- 6.1 The price should be firm and irrevocable and not subject to any change whatsoever even due to Increase in cost of materials, components and labour cost till the validity of the contract period.
- 6.2 The quoted rates shall be valid for a period of minimum 30 days from the date of opening the price Bid.

#### 7. Notification of Award

Prior to the expiration of the period of Bid validity, BL will place purchase order or letter of intent on the successful bidder(s).

#### 8. Earnest Money

Before the last date and time of bid opening, the bidder is required to submit at Chennai office (please refer Notice Inviting Tender) the EMD of Rs.3000/- (Rupees Three thousand only) by way of a bank draft payable at Chennai favoring Balmer Lawrie & Co Ltd.
