1.2 Digital Certificate authentication

SCOPE OF WORK

The successful tenderer shall have to undertake the following work:

- 1. The Medical Advisor (Doctor) will be engaged on retainer basis. The engaged Doctor should visit CFS for 2 days in a week for 2 hours on each day and provide consultations /diagnosis to employees /staff who are approaching him during the schedule time and date.
- 2. The day and the time of the visit will be informed by the company.
- The engagement of the doctor will be for a period of 1 year and this doesn't guarantee any
 job position in the company. This is purely based on retainership basis and shall not be
 construed as establishing an employee employer relationship between Doctor and our
 Company.
- 4. The doctor should bring his own equipments such as stethoscopes, BP checking equipment etc and only a room/adequate space will be provided by the company during his visiting hours.
- 5. The details about the Doctor visiting CFS should be informed along with the tender document. Moreover it is proposed to depute only one doctor for the entire period of 1 year in order to have continuity of treatments/diagnosis so that the employee or staff medical history is known to the doctor.
- 6. In case of absence of doctor on any scheduled day, the company at its own cost arrange an alternate doctor and the payment towards the same will be deducted from the monthly bills.
- 7. During the period of retainership, doctor will be deemed to be the Medical Advisor to the Company and shall exercise such authorities as are applicable to Medical Advisor including vetting of reference to medical specialists. However, Doctor will have no other administrative or financial authorities.

GENERAL TERMS AND CONDITIONS

1. Eligibility Criteria For Techno-Commercial Bid

a) Payment of Interest Free EMD of Rs. 3000/-

Note: EMD is exempted for the MSME and NSIC registered vendors however they have to produce valid registration certificate.

- b) Appointed Doctor must be registered with the General Medical Council (GMC) and hold a licence to practice and be fully engaged with GMC revalidation.
- c) Appointed Doctor should be have at least minimum MBBS Qualification.
- d) The experience should be not less than 5 years and the same should be supported by certificates from hospitals worked earlier.

2. Tender Opening

Unprice and price bid will be opened as per tender calendar as it is a single bid.

3. Acceptance of offers

- 3.1 Bids of any tenderer may be rejected if a conflict of interest is detected between the bidders and Balmer Lawrie at any stage.
- 3.2 Balmer Lawrie is not bound to accept the lowest rate for any tender. Balmer Lawrie also reserves its right to allow Public Enterprises (Central / State) price / purchase / contract / service preference as admissible under the existing Government policy. The decision of Balmer Lawrie in this connection will be final.
- 3.3 Incomplete tenders, conditional tenders, tenders received late or tender not conforming to the terms and conditions mentioned in the Tender documents or not accompanied by the requisite Earnest Money Deposit (unless exempted under the terms of this Tender) will be rejected.

4. Negotiations

- 4.1 Balmer Lawrie reserves the right to negotiate with the Tenderer. Tenderer will have to attend the concerned office of Balmer Lawrie for negotiations/clarifications required from them, in respect of their quotations, without any commitment on the part of Balmer Lawrie.
- 4.2 In case of negotiation, the Tenderer should send the confirmation of outcome of such negotiation in writing so as to reach the concerned office of Balmer Lawrie within 3 days from the date of negotiation/ the time stipulated. If the Tenderer fails to comply with this requirement Balmer Lawrie reserves its right to ignore their quotation at its discretion with the attendant remedies available to them.

5. Price Variation

- 5.1 The price should be firm and irrevocable and not subject to any change whatsoever even due to increase in cost of materials, components and labour cost till the validity of the contract period.
- 5.2 The quoted rates shall be valid for a period of minimum 60 days from the date of opening the price Bid.

6. Notification Of Award

Prior to the expiration of the period of Bid validity, BL will place purchase order or letter of indent on the successful bidder(s).

7. Contract Period

The contract will be for a period of [12 months effective from the date of LOI] or such date as may be mutually agreed. On satisfactory performance during the initial contract period of [12] months], the contract may be extended at the discretion of the Company for another period of one year on the existing terms & conditions. Also retainership contract can be terminated by giving two month notice in writing in case of poor performance.

8. Security Deposit / EMD

The Earnest Money Deposit of the successful bidder would also be retained as Security Deposit till the date of Supply of the materials. . EMD of unsuccessful bidders will be returned after finalization of the contract.

10. Payment Terms

The payment will be released against certified bills within 7 (Seven) days from the date of completion of work on monthly basis.

11. Arbitration

Any dispute or difference arising under this Contract shall be referred for adjudication at Kolkata to a Sole Arbitrator to be appointed by the Chairman & Managing Director, Balmer Lawrie & Co. Ltd. and the provisions of Arbitration Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings.
