Technical Specification for pH Meter

2. **Submission of offer:** - Bidder shall submit their sealed offer in a single bid/envelope, superscripting the envelope with tender No., date & due date along with following enclosures- Covering letter with your reference number & date. Acknowledgment of General Terms & Conditions (Annexure-B) Price schedule (Annexure-C)
3. **Standard Accessories:** All standard accessories as per the lists mentioned in Annexure A above required for operation and maintenance of the equipment shall be supplied with the equipment.
4. **User manuals and instruction booklets:** this shall be supplied with the equipment.
5. **Selection & placement of offer:**
Balmer Lawrie & Co. Ltd. reserves the right to place the 'Purchase Order', which will be placed on the individual(s) technically & commercially qualified vendor(s), whose total prices are found lowest.
6. **Jurisdiction:** - All disputes are subject to Silvassa jurisdiction.

8. **Liquidated damages:**-Vendor shall be liable to pay liquidated damages for the following:
Failure to complete supply of item to BL within the scheduled period. In such case, vendor shall be liable to pay liquidated damages @ **0.5%** of PO value per week or part thereof subject to a maximum of **5.0%**.
