2. Collection of delivery orders from various offices viz. Liner / NVOCC / Shipping Agent office.
3. Filing / Processing of Bill of Entry Execution of Bond formalities and to custom clear the import consignments at COCHIN SEAPORT
4. To load the customs cleared consignments in to our designated transporter from COCHIN SEAPORT
5. Any deficiency in clearance documents should be reported to Balmer Lawrie immediately.
6. Completion of customs formalities and to load the customs cleared consignment within the free period from the date of receipt of clearance documents from our Office. In case of any delay in clearance on the part of clearing agent, the proportionate warehouse charges and container detention charges will be deducted from clearing agents bills.
7. In case if the clearing agent observes any damage to containers/consignments, the same need to be notified to Balmer Lawrie and necessary OD certificate to be collected by the clearing agent from the concerned warehouse.
