Online bids are invited from authorized agents only having offices in Kolkata with sound infrastructural, technical and financial capabilities. Please arrange to send your E-bid (email/fax/ hard copies of offer will not be accepted) for **supply of new cartridges as detailed in Annexure I.** (Bidders are requested to submit prices in E-bid portal & all other supporting documents including signed copy of tender, authorization certificate & EMD in hard copies - sealed bid (without price))

Quantity: Refer Annexure I. The quantities are only an indicative figure and not a binding, which may change at the time of ordering OR during the contractual period.

Basis of Selection: The basis of selection of vendors and allocation of order quantity shall be as under.

- a) The price offers of only the technically successful bidders will be considered for further evaluation for placement of order.
- b) The on-line closed bids shall be used for grading the bidders .The lowest quoted bidder on net landed basis in the on-line closed bids shall be designated as "L1" and the next lowest quoted bidder as "L2" and so on in the grading system.
- c) Orders will be placed on L1 vendor based on each item (technically accepted).

Price basis: The price quoted shall be firm for the entire period of contract. Statutory charges such as excise duty, sales tax or other levies shall be payable at actual.

Period of Contract: Twelve months from date of LOI/PO.

Delivery Schedule: Supplies has to be executed against or written call ups. Material has to be supplied within 2 days from the date of call up. Call UP quantity shall be decided by Balmer Lawrie and may start with 1 nos also.

Delivery Charges: Supply should be on door delivery basis. No extra charges will be paid by Balmer Lawrie towards freight charges.

Payment Terms: 30 days from the date of receipt of material at our Works.

Validity of offer: 30 days from the due date.

Earnest Money Deposit (EMD): EMD of Rs. 5000/- by bank draft or pay order drawn in favour of "Balmer Lawrie & Co. Ltd. Payable at Kolkata. No interest will be payable on EMD. Bid not accompanying with EMD shall be rejected. EMD of unsuccessful bidders will be released after finalization of order. The EMD amount of successful bidder shall be converted into Security Deposit. SD will be released after 10 days of successful completion of the order. No interest shall be payable for EMD/SD.

CONDITIONS FOR ONLINE BID SUBMISSION

Procedure For Bid Submission

The bidder shall submit his response through bid submission to the tender on eProcurement platform at https://balmerlawrie.eproc/.in by following the procedure given below. The bidder would be required to register on the e-procurement market place at https://balmerlawrie.eproc/.in and submit their bids online. No offline bids shall be entertained by the Tender Inviting Authority. The bidders shall submit their eligibility and qualification documents, Technical bid, Financial bid etc., in the standard formats prescribed in the Tender documents, displayed in eProcurement web site. The bidders shall upload the scanned copies of all the relevant certificates, documents etc., if required, in support of their eligibility criteria/technical bids in the eProcurement web site. However, bulky documents need not be scanned and uploaded but physical copy of the same should be sent to the Tender Inviting Authority office before the tender opening date. The bidder shall sign on the statements, documents, certificates, uploaded by him, owning responsibility for their correctness/authenticity.
