Eligibility Criteria

- 1. Experience in supplying similar equipments to PSU Oil Company or other reputed Public/Private Limited Company (PO copies / other documentary evidences to be enclosed). At least three purchase orders of last three years of similar machine to be enclosed with Technical Bid
- 2. Vendor should match the technical specifications given in annexure A.
- 3. Annual Turnover of the vendor should be Rs 1 Cr or above in each of last three years.
- 4. If any distributor is participating/bidding, then they have to enclose the authorization certificate of the original equipment manufacturer.
- 5. Vendor should have the after-sales service network within 300 kms from Silvassa e.g. Mumbai, Pune, Nasik, Surat etc. and provide the details of the same.


