SCOPE OF WORK

Work covered in this tender document shall generally be as detailed herein below. However, contractor shall be responsible to complete the work in all respects and in doing so provide/supply all facilities which may not be covered below explicitly but nevertheless are required to complete the work envisaged with the exception of only such items as have been specifically excluded from contractor's scope.

The successful tenderer shall have to undertake the following work:

Destruction of unclaimed cargo lying in "As is where is basis" from our Container Freight Station, Manali, Chennai 600068 covering the following works:

- Obtaining Customs dock and preventive escort permission including misc expenses
- Obtaining necessary clearances from Pollution Control Board
- Obtaining permission from Corporation / Municipality including dump yard charges, ground pit expenses, JCB crane hire charges and labour charges

Quantity and weight of cargo: 25 M.T packed in 1000 bags of 25 kgs each stored in 40ft container

Arranging necessary transportation for movement of loaded container from our premises to dump yard, bringing back the empty container and providing car to CFS preventive officer would be in our scope.

GENERAL TERMS AND CONDITIONS

1. Experience Criteria For Techno-Commercial Bid

- a) The bidder should have experience in carrying out disposal of waste/scrap cargo for one year during the last three years ending 31.12.16.
- b) Bidder must have GST Registration number (Proof to be attached)
- d) Should not have been blacklisted by any PSU / Govt. Department (a self- certification is required). This is subject to verification by Balmer Lawrie and if found to be false, the bidder may be debarred from participating in the tender, or order already placed will be cancelled

2. Submission Of Bids

Delivery schedule is subject to force majeure conditions as under: If at any time during the continuance of this contract, the performance in whole or part by either party of any obligation under this contract shall be prevented or delayed by reasons of any war, hostility, acts of public enemy, civil commotion sabotage, fire, floods, explosions, epidemics, quarantine restrictions, strikes, lock outs or acts of God (hereinafter referred as "events") provided notice of the happening of any such events is given by either party to the other within twenty one days from the date of occurrence thereof, neither party shall by reasons of such event, be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such non-performance or delay in performance. Deliveries under the contract shall be resumed as soon as practicable.

13. Arbitration

Any dispute or difference arising under this Contract shall be referred for adjudication at Kolkata to a Sole Arbitrator to be appointed by the Chairman & Managing Director, Balmer Lawrie & Co. Ltd. and the provisions of Arbitration and Conciliation Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings. The fees of the Arbitrator, if any, shall be shared equally by both the parties.
