#### 2. Filling of Tender Documents

- 2.1 The tenderers are requested to carefully study all the tender documents and tender conditions before quoting their rates.
- 2.2 The tender must be strictly in accordance with the terms and conditions and specifications laid out in the tender.
- 2.3 Any terms and conditions given by the tenderer in their offers will not be binding on Balmer Lawrie.
- 2.4 The sole proprietor or authorised representative shall sign all documents that needs to be uploaded. When the person signing the documents is not the sole proprietor / authorised representative of the company, the Power of Attorney authorizing such person to act and sign on behalf of the company must be produced.

#### **SCOPE OF WORK**

From time to time, Balmer Lawrie CFS will be providing the details of longstanding cargo to be valued. It would be the responsibility of the selected bidder to arrange for physical inspection of cargo in Containers/Destuffed Cargo or LCL Lots, draw samples, if felt necessary for inventory and valuation of Cargos. For inspection of the cargo, Balmer Lawrie will arrange for grounding of Containers, services of carpenter/labour etc. for lifting and shifting of cargo to facilitate proper inspection of the cargos. Valuation reports should be prepared as per laid down procedures of the Custom and to be submitted within 7 days from the date of inspection of cargo at our CFS. Strict confidentiality should be maintained with regard to valuation of the cargos.

#### **GENERAL TERMS AND CONDITIONS**

#### 1. Eligibility Criteria For Techno-Commercial Bid

The bidders shall meet the following criteria:

- Average Turnover of not less than Rs. 10 lakhs (Ten lakhs) during the last 3 financial years ending on 31.3.2016. Supporting documents regarding turnover, viz. Balance Sheet and Profit & Loss Account or a certificate from a Chartered Accountant, shall be enclosed with Techno Commercial Bid(Part-A).
- Bidder shall have at least 3 years' experience of working as Valuer out of which at least one year
  experience in conducting valuation of longstanding cargo for any CFS in JNPT, Navi Mumbai
  area or for Customs in Mumbai or Navi Mumbai.
- Bidder should have valid GST Registration number, proof of the same to be submitted.
- Payment of EMD of Rs.3000 /-

#### 2. Submission Of Bids

The bids should be submitted in single bid process

Technical / Commercial Bid [Unpriced] with Price bid

For Price Bid, only the rates are to be submitted as per given format.

#### 2. Tender Opening

Unprice and price bid will be opened as per tender calender.

#### 3. Acceptance of offers

- 3.1 Balmer Lawrie reserves the right to accept any tender in whole or in part or reject any tender or all tenders or place order for any quantity, less than or more than the tendered quantity, without assigning any reason thereof.
- 3.2 Bids of any tenderer may be rejected if a conflict of interest is detected between the bidders and Balmer Lawrie at any stage.
- 3.3 Balmer Lawrie is not bound to accept the lowest rate for any tender. Balmer Lawrie also reserves its right to allow Public Enterprises (Central / State) price / purchase / contract / service preference as admissible under the existing Government policy. The decision of Balmer Lawrie in this connection will be final.
- 3.4 Incomplete tenders, conditional tenders, tenders received late or tender not conforming to the terms and conditions mentioned in the Tender documents or not accompanied by the requisite Earnest Money Deposit (unless exempted under the terms of this Tender) will be rejected.

#### 4. Negotiations

- 4.1 Balmer Lawrie reserves the right to negotiate with the Tenderer. Tenderer will have to attend the concerned office of Balmer Lawrie for negotiations/clarifications required from them, in respect of their quotations, without any commitment on the part of Balmer Lawrie.
- 4.2 In case of negotiation, the Tenderer should send the confirmation of outcome of such negotiation in writing so as to reach the concerned office of Balmer Lawrie within 3 days from the date of negotiation/ the time stipulated. If the Tenderer fails to comply with this requirement Balmer Lawrie reserves its right to ignore their quotation at its discretion with the attendant remedies available to them.

#### 5. Price Variation

- 6.1 The price should be firm and irrevocable and not subject to any change whatsoever even due to increase in cost of materials, components and labour cost till the validity of the contract period.
- 6.2 The quoted rates shall be valid for a period of minimum 60 days from the date of opening the price Bid.

#### 8. Security Deposit / EMD

The Earnest Money Deposit of the successful bidder would also be retained as Security Deposit till completion of the contract/extended contract period. **Parties with Valid MSMED/ NSIC Certificates is exempted from EMD.** EMDs of unsuccessful tenderers shall be refunded only after finalization of tender.

#### 9. Payment Terms

Payment would be released by cheque within 15 days of submission of bidders invoice mentioning clearly the successful e-Auction and Tender cum e-Auction & valuation conducted over a month and giving calculations of their share of service charges. GST will be extra as applicable.

#### 9. LIABILITY

The selected tenderer will be fully responsible to keep BL-CFS indemnified in case of any liability arising/claim being made on Balmer Lawrie due to any fault attributable to the tenderer for the conduct of valuation.

#### 10. Sub-letting of Work

No part of the contract or any share or interest therein shall in any manner or degree be transferred, assigned or sublet by the contractor directly or indirectly to any person, firm or corporation without the consent in writing from Balmer Lawrie. In the event of contractor contravening the conditions, Balmer Lawrie shall be entitled to get the work done from other firm at the 'Risk & Cost' of the contract.

#### 11. Indemnity

The Contractor will be required to indemnify and keep indemnified the Company against all losses and claims for injury and damage to any person or any property whatsoever which may arise out of or in consequence of the work and against all claims, demands proceedings damages, cost charges and expenses

whatsoever. The company may forward the bidder any such claim demand or complaint made by any other person against the company. In such event, the contractor shall solely be liable for the disposal of

the said complaint. The contractor will be required to Indemnify and absolve the Company of all responsibilities related to employment condition of their employees and should adequately safeguard Company against any possible IR problems including those related to employment. The bidder should adhere to all State and Central Enactments related to employment such as Minimum Wages Act, Workmen Compensation Act, Provident Fund Act, Employees State Insurance Act, Gratuity Act, Bonus Act, Contract Labour [Regulations and Abolition] Act etc. Further, Company will not have any liability towards employment, remuneration or compensation in whatever manner made to the employee of the bidder.
