- 3) The leased vehicle will be an all-sides (incl. roof) closed body vehicle. vehicle should be properly painted and bear the name of the Balmer Lawrie Logistics Services Along with Company's logo at transporter's cost.
- 4) The vehicle will be made available to us during normal working from 10 am to 10 PM / 9am to 9 PM, as per the requirements of the branch, on all working days including Saturdays.

- 5) Vehicle will be used for transportation of cargo within the twin cities of Hyderabad/ Secunderabad including outskirts.
- 6) Contractor will be responsible for payments on account of fuel, running, repairs & maintenance, upkeep, insurance, safety, taxes or levy or any penalty for any reason in relation to the vehicle except service tax, if any, which shall be payable as per applicable law. For the purposes of quotation, you are required to presume monthly coverage of appr. 2500 kms.
- 7) Drivers of the transporter should hold valid driving licenses, Valid RC Book & Insurance copy. Contractor will be solely responsible to comply with all local laws relating to running/ownership of such commercial vehicles and shall arrange all State permits in advance at his costs only.
- 8) In case of detention of vehicles due to any lapse on the part of the transporter or its drivers or the ownership of the vehicles, no claim for detentions charges shall be entertained by the company.
- 9) One spare stepney and complete tool kit must be available with vehicle.
- 10) A driver and a cleaner/helper must be available all the time during loading, transit & unloading of the consignments.
- 11) In case of any break-down/detention of the vehicles due to any failure on the part of the transporter, it will be contractor's responsibility to provide alternative arrangements for transportation at transporter's costs only failing which per day penalty will be imposed on the transporter
- 12) In case of any loss incurred by us due to non-delivery/late delivery/misplacement/damage of the consignment while under the possession of the transporter, the damages claimed by the client are recoverable from the contractor.
