## 3 LD CLAUSE

Timely delivery is the essence of the order. In case of delay in supplying the material at Balmer Lawrie's (BL) plant beyond the lead time mentioned in clause no: 2, a pre-determined reduction of price to sum equivalent to 0.5% of the basic order value of the delayed supplies per week or part thereof subject to a maximum of 5% of the basic order value will be applicable.

Further, BL, at their own option may go in for Risk Purchase for not delivering the material beyond 1 (one ) month of the date of call up and in such instances Security Deposit will be forfeited.

## 4 PAYMENT TERMS

30 days from the date of receipt of the material and acceptance of same after necessary quality checks by our Quality Assurance Department.

## 5 <u>VALIDITY</u>

The offer shall remain valid for a period of <u>**30 days**</u> from the due date of the tender.

## 6 EARNEST MONEY DEPOSIT (EMD) & SECURITY DEPOST (SD)

EMD of Rs. 5,000/- by Pay Order / Demand Draft from Schedule "A" Bank drawn in favour of Balmer Lawrie & Co. Ltd. Payable at Kolkata ( P 43 Hide Road Extension Kolkata 700088 ) shall be submitted with the bid. Bid not accompanying with EMD shall be rejected. EMD of unsuccessful bidders will be released after finalization of order. The EMD amount of successful bidder shall be converted into Security Deposit. SD will be released after 10 days of successful completion of the order. No interest shall be payable for EMD/SD.

## **Procedure For Bid Submission**

The bidder shall submit his response through bid submission to the tender on e-Procurement platform at <a href="https://balmerlawrie.eproc.in">https://balmerlawrie.eproc.in</a> by following the procedure given below. The bidder would be required to register on the e-procurement market place at <a href="https://balmerlawrie.eproc.in">https://balmerlawrie.eproc.in</a> and submit their bids online. No offline bids shall be entertained by the Tender Inviting Authority. The bidders shall submit their eligibility and qualification documents, Technical bid, Financial bid etc., in the standard formats prescribed in the Tender documents, displayed in eProcurement web site. The bidders shall upload the scanned copies of all the relevant certificates, documents etc., if required, in support of their eligibility criteria/technical bids in the eProcurement web site. However, bulky documents need not be scanned and uploaded but physical copy of the same should be sent to the Tender Inviting Authority office before the tender opening date.
