8. Completion period

During Warranty Period of one year all maintenance cost to be borne by the Vendor. In case of non-functioning of the blower fan, vendor's technicians should report within four (4) hours of our Phone Call/Mail during working hours.

12. Sub-letting of Work

No part of the contract or any share or interest therein shall in any manner or degree be transferred, assigned or sublet by the contractor directly or indirectly to any person, firm or corporation without the
