SCOPE OF WORK

Work covered in this tender document shall generally be as detailed herein below. However, the agency shall be responsible to complete the work in all respects and in doing so provide all facilities which may not be covered explicitly herein below but nevertheless are required to complete the work envisaged with the exception of only such items as have been specifically excluded from vendor's scope.

The successful tenderer shall have to undertake the following work:

Detailed Scope of work:

Providing consultancy and certification work for certification of ISO 9001:2015 for our Container Freight Station, Manali, Chennai 68 covering the following

- i. Assessment of Existing system for adequacy to ISO 9001:2015 requirements, guide to appoint the Management Representative, the core group and personnel related to these, training for total awareness and undertaking of the system, its documentation, statistical techniques, quality procedures etc by systematic training and supply of necessary training material, finalizing the draft Quality Policy and Quality Objectives and to make a systematic training programmer and a details, plan for Completion of the work. Formulation of the scope of certification with the exclusions [if any] and final Quality Policy and Quality Objectives.
- ii. Evaluation and guidance in development in quality manual, system documents, quality procedures and assist in completion of documentation required for certification to ISO 9001:2015. This will involve one to one interaction with the executives related to the activities under Quality Management System for counseling and completion of their documentation keeping in consideration the linkage with ISO 9001:2015 standards. Identify the work instruction needed for various processes of the unit and guide in development of the work instructions thus identified. Identify the Quality Plans for various activities in the unit and guide and assist in completion of quality plans suitable for certification to ISO 9001:2015
- iii. Issue of Quality Manual and Quality Procedures. Work Instructions and Quality Plans, Implementation of Quality System Documents and their Control.
- iv. Assistance and guidance in the use of suitable statistical techniques/tools to be used in the unit. Conduct Internal Auditor Training Course for our personnel and provide the Training Material.

- 3) Should have minimum turnover of Rs.50,000/- per year during the last 3 years ending 31st March 17. (Proof to be attached).
- 4) The Bidder must have GST Registration (Proof to be attached)
- 5) Should not have been blacklisted by any PSU / Govt. Department (a self-certification is required and should be attached)

4. Acceptance of offers

- 4.1 Balmer Lawrie reserves the right to accept any tender in whole or in part or reject any tender or all tenders or place order for any quantity, less than or more than the tendered quantity, without assigning any reason thereof.
- 4.2 Bids of any tenderer may be rejected if a conflict of interest is detected between the bidders and Balmer Lawrie at any stage.
- 4.3 Balmer Lawrie would like to place order for all the items of work as mentioned in the Price bid to a single contractor. The overall L1 status will be determined by looking at the total value quoted by the bidder.
- 4.4 Balmer Lawrie is not bound to accept the lowest rate for any tender. Balmer Lawrie also reserves its right to allow Public Enterprises (Central / State) price / purchase / contract / service preference as admissible under the existing Government policy. The decision of Balmer Lawrie in this connection will be final.

If the Tenderer fails to comply with this requirement Balmer Lawrie reserves its right to ignore their quotation at its discretion with the attendant remedies available to them.

6. Price Variation

- 6.1 The price should be firm and irrevocable and not subject to any change whatsoever even due to Increase in cost of materials, components and labour cost till the validity of the contract period.
- 6.2 The quoted rates shall be valid for a period of minimum 60 days from the date of opening the price Bid.

8. Validity of contract

9. Payment Terms

- b) 20% payment after completion of Certification audit by the Certifying body
- c) 40% payment on receipt of certificate of 1st surveillance audit in 2019
- d) 20% payment after completion of 2nd surveillance audit in 2020.

10. Sub-letting of Work

No part of the contract or any share or interest therein shall in any manner or degree be transferred, assigned or sublet by the contractor directly or indirectly to any person, firm or corporation without the consent in writing from Balmer Lawrie. In the event of contractor contravening the conditions, Balmer Lawrie shall be entitled to get the work done from other firm at the 'Risk & Cost' of the contract.

11. Indemnity

The Contractor will be required to indemnify and keep indemnified the Company against all losses and claims for injury and damage to any person or any property whatsoever which may arise out of or in consequence of the work and against all claims, demands proceedings damages, cost charges and expenses whatsoever while carrying out the work inside the CFS. The company may forward the bidder any such claim demand or complaint made by any other person against the company. In such event, the contractor shall solely be liable for the disposal of the said complaint. The contractor will be required to Indemnify and absolve the Company of all responsibilities related to employment condition of their employees and should adequately safeguard Company against any possible IR problems including those related to employment.

12. Force Majeure Conditions

Completion of work is subject to force majeure conditions as under: If at any time during the continuance of this contract, the performance in whole or part by either party of any obligation under this contract shall be prevented or delayed by reasons of any war, hostility, acts of public enemy, civil commotion sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lock outs or acts of God (hereinafter referred as "events") provided notice of the happening of any such events is given by either party to the other within twenty one days from the date of occurrence thereof, neither party shall by reasons of such event, be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such non-performance or delay in performance. Completion of work under the contract shall be resumed as soon as practicable.

13. Arbitration

Any dispute or difference arising under this Contract shall be referred for adjudication at Kolkata to a Sole Arbitrator to be appointed by the Chairman & Managing Director, Balmer Lawrie & Co. Ltd. and the provisions of Arbitration and Conciliation Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings. The fees of the Arbitrator, if any, shall be shared equally by both the parties.
