be submitted in duplicate. Also soft copy to be submitted

immediately thereafter.

[2] CODE OF PRACTICE: BIS Code of practice or equivalent international standard must be

followed in preparing the structural design & drawings.

## **GENERAL TERMS & CONDITIONS**

### 01. Eligibility Criteria For Techno-Commercial Bid

- a) Consultant or Consulting Agency must be/ have qualified/Graduate Civil/Structural Engineer who shall design the structure, prepare drawing and structural analysis works and BOQ etc.
- b) Should have minimum Average Financial Turnover of Rs. 4.0L per year during the last 3 financial years ending with March 2017(Proof to be attached).—Audited accounts or CA certificate.
- c) Should not have been blacklisted by any PSU /Govt. Department (a self-certification is required).

#### 02. SITE VISIT.

The Tenderer, at the Tenderer's own cost/responsibility is advised to visit for assessing and taking necessary measurements and examine the Site of Work and its surroundings and obtain all information that may be necessary for preparing the Tender before submission of their tender, for providing its Consultancy services

#### **03. DELIVERY PERIOD:**

- Structural design with analysis & drawing to submitted within 2 weeks of P.O/Availability of Access & measurement of the site under consideration.
- BOQ to be prepared and submitted within 3 weeks of P.O.
- Details working drawing to be submitted within 4 weeks of P.O.
  - **04.** <u>VALIDITY</u>: Your quoted rate shall be valid for a period of 120 days time from date of your tender offer or 2 months from the date of our P.O. which ever is later.

#### 05. Liquidated Damage

- (i) If the vendor is unable to render its services specified in the scope of work within the period specified and in synchrocity with the progress of Structural Work by any other successful vendor, he may request the owner for extension of time with unconditionally agreeing for payment of LD. Upon receipt of such a request, owner may at its discretion extend the period of completion and shall recover from the consulting agency, as an ascertained and agreed Liquidated Damages, a sum of 1% of contract value for each week of delay or part there of subject to a maximum of 10% of contract value.
- ii) Notwithstanding what is stated in Clause above, the Owner shall have the right to employ any other agency to complete the remaining work at the risk and cost of the Consulntant.

- **06. PAYMENT TERMS**: [a] 70% of the individual item value shall be released after 15 days of receipt of the schedule consultancy services as per schedule of services in Price Schedule.
  - [b] Balance 30% of the entire order value shall be released after 30 days of execution of all works.
  - [c] All payment shall be subject statutory deductions as per norms.
- **07. Taxes & Duties**: Rates to be quoted shall be inclusive of all charges. However, GST, if any shall be paid by BL extra as applicable.

#### 08. Arbitration

Any dispute or difference arising under this Contract shall be referred for adjudication at Kolkata to a Sole Arbitrator to be appointed by the Chairman & Managing Director, Balmer Lawrie & Co. Ltd. and the provisions of Arbitration and Conciliation Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings. The fees of the Arbitrator, if any, shall be shared equally by both the parties.
