Balmer Lawrie invites Online Tenders for supply of 3 MT [+/- 10%] of **Graphite Powder at our Chennai plant** as per IS :495-1967 and as per the following specification as given below :

Petroleum ether soluble matter, % by weight [Test Method A3]	: 0.50 max
Water soluble matter,% by weight [Test Method A4]	: 1.25 max
Acidity of water extract [Test Method A5]	To satisfy the requirement Of the test.
Ash, % by weight [Test Method A-6]	: 5.0 max
Non- Graphite carbon, % by weight [Test Method A7]	: 3.0 max

Your offer should be on door delivery basis clearly specifying Basic Price, freight charges, GST percentage, Material HSN code, Company GST registration Number, delivery period, packing size, if any, etc.

Provisions for Micro , Small and Medium Enterprises (MSME) :

- Qualification Criterion : MSME vendor must confirm that UAN No has been uploaded on CPPP website as required by minister vide circular no F:No21(17) / 2016 dated 06.04.18 for qualifying to be considered as MSME vendor under this tender.

Payment terms: Full payment within 30 days from the date of receipt of material at our respective plants in good condition.

Basis Of selection:- L1 bidder will be selected location wise.

Offer shall clearly indicate the following:

3. System to control air emissions, effluents and hazardous waste disposal system to comply with regulatory requirement?
4. Do any of your operations results in the creation of hazardous waste? If yes, is there a system in place to identify and properly dispose of hazardous waste?

Procedure For Bid Submission

The bidder shall submit his response through bid submission to the tender on eProcurement platform at <https://balmerlawrie.eproc.in> by following the procedure given below. No offline bids shall be entertained by the Tender Inviting Authority. The bidders shall submit their eligibility and qualification documents, Technical bid, Financial bid etc., in the standard formats prescribed in the Tender documents, displayed in eProcurement web site. The bidders shall upload the scanned copies of all the relevant certificates, documents etc., if required, in support of their eligibility criteria/technical bids in the eProcurement web site. However, bulky documents need not be scanned and uploaded but physical copy of the same should be sent to the Tender Inviting Authority office before the tender opening date. The bidder shall sign on the statements, documents, certificates, uploaded by him, owning responsibility for their correctness/authenticity.
