How General Planned Inspection (GPI) can reduce major incident

When we encounter potential hazards in our personal life, we take action to protect ourselves and others. In our professional life, we should act in the same way. It is our responsibility, irrespective of function or position, to act in a preventive way and to initiate appropriate actions. Immediate causes of accidents often correspond to deviations that have been observed. To help remove hazards, "General Planned Inspections" (GPI), are usually carried by the line managers. As part of this the line managers:

- 1. Identify deviations from the standards
- 2. Analyze these deviations to find the root causes
- 3. Implement suitable control measures and/or corrective actions
- 4. Give feedback and suggestions



The purpose of giving suggestions and feedback is to allow for continuous improvement of the processes and to enhance the protection of personnel and the environment. It is everyone's responsibility to participate in GPIs and Safety Observation Visits!

In recently conducted HSE Review at CFS Manali, it was observed that the entire line management is involved in conducting GPI on a daily basis. Through this CFS Manali proactively identifies the deviations & initiates action to mitigate the hazard & prevent incidents.



The Ananda Bhairavi Temple in Sukharia village near Somra Bazar raliway station in Hoogly District has an extremely rare form of temple architecture. Built in 1813 by Bireshwar Mustafi, the three-storeyed Ananda Bhairavi temple is crowned with 25 pinnacles. The approach to the Ananda Bhairavi temple, housing the idol of Anandamoyee Kali, is flanked by two parallel rows containing six temples each. Five of the temples on each row are aatchalas (eight-sloped roof). One temple on each flank has a pancharatna (five-pinnacle) roof. One of the pancharatna temples is dedicated to Ganesha, while the other nine house shivalingas. Sukharia village has the distinction of being the site of some of the finest temple architecture of Bengal. It takes around one and a half hours to reach Somra Bazar from Howrah station.
