The brief profile of Smt. Perin Devi Rao and other details are as hereunder:

Smt. Perin Devi Rao

Smt. Perin Devi Rao was appointed as additional Director under the category of Government Nominee Director on the Board of the Company on 28th July, 2018 based on direction received from the Ministry of Petroleum and Natural Gas (MOPNG). She was further appointed as the Government Nominee Director of the Company at the 101st AGM of the Company held on 12th September, 2018 for a period of 3 years with effect from 26th July, 2018 on co-terminus basis or until further orders of the Administrative Ministry, whichever is earlier. Upon completion of her tenure Smt. Perin Devi Rao ceased to be the director of the Company with effect from 26th July, 2021.

Further vide Office Memorandum No. C-31033/1/2016-CA/FTS:42979 dated 5th August, 2021 from the Administrative Ministry, Ministry of Petroleum & Natural Gas (MOPNG) – Smt. Perin Devi Rao, Director (IFD), MOPNG, was nominated as Government Nominee director on the Board of the Company with effect from 5th August, 2021 for a period of three years on co-terminus basis or until further orders, whichever is earlier.

Smt. Perin Devi Rao was appointed as a Non-executive, Additional Director under the category of Government Nominee Director on the Board of the Company with effect from 6th August, 2021 based on the direction received from the MOPNG.

Further, as per the requirement of the Circular no. LIST/COMP/14/2018-19 dated 20th June, 2018 and Circular no. NSE/CML/2018/24 dated 20th June, 2018 issued by BSE Ltd. and National Stock Exchange of India Limited, respectively on the subject of enforcement of SEBI Orders dated 14th June, 2018 regarding appointment of Directors by listed companies, we hereby affirm that Smt. Perin Devi Rao (DIN: 07145051) is not debarred from holding the office of director by virtue of any order of SEBI or any other such authority.

Smt. Perin Devi Rao does not have any inter-se relationship with other directors of the Company.
