
# Container Freight Station

Balmer Lawrie has three state-of-the-art Container Freight Stations (CFSs) in Mumbai, Chennai and Kolkata with warehousing and distribution facilities in Kolkata and Coimbatore. This is testimony to our ability to successfully handle a whole range of cargo promptly and safely 24 x 7. The CFSs are fully equipped for secure handling and on-time delivery of cargo, whether it is over-dimensional, perishable, temperature-sensitive or standard cargo.

CFSs are AEO certified with ISO 9001:2008, ISO 14001:2015 and OHSAS 18001:2007 accreditation.

- 84,000 sq.ft. covered warehouse

## Chennai CFS

- Chennai CFS started operations in the year 2000
- Spread over a vast area of 22.78 acres
- Strategically located, 12 kms from Chennai Port and 19 kms from Ennore and Kattupalli Port
- 100 trailers on long-term contract for movement of containers
- 3 Reach Stackers, 9 Forklifts, 40 MT Crane, Telescopic Mobile Cranes and 80 MT Weighbridge
- 85,000 sq.ft. of covered warehouse for export and import cargo

## Kolkata CFS


- Established in 1994, Kolkata CFS was the first to be set up in the eastern region
- Spread over a vast area of 16 acres
- Strategically located 2.5 kms from Kolkata Dock
- A pioneer in EDI (Electronic Data Interchange) connectivity in the eastern region
- A dedicated Rail siding with merry-go-round facility with its own Rail Flats
- The CFS is connected to Kolkata Dock System & Haldia Dock Complex
- 3 Reach Stackers and 2 Weighbridge upto 100 MT capacity
- Total covered warehouse space of 80,000 sq.ft.

## Multi Modal Logistics Hub

Balmer Lawrie has set up a Multi Modal Logistics Hub (MMLH) at Visakhapatnam in a Joint Venture (JV) with Visakhapatnam Port Authority (VPA) for handling Export-Import (EXIM) and domestic cargo. Set up on 53 acres of land, the MMLH has a 1.36 km track for railway connectivity and can handle four rakes in a day. The hub is the only facility to have direct connectivity with the port for seamless movement of laden import and export consignments. Services include:

- EXIM – CFS / ICD, warehousing
- Cold storage / temperature controlled warehouse
- Paved yard for storage of container and cargo
- Hazardous / non-hazardous cargo handling and truck parking

The hub includes a non-bonded / non-notified domestic area with container storage, general warehousing, cold storage, open cargo storage, empty container storage, truck parking, repair and maintenance area for containers.

### Kolkata

Warehousing & Distribution (W&D), Kolkata, has traditionally been a stockyard operator specializing in ferrous material handling. In recent years it has forayed into modern warehousing and distribution services with two units in Kolkata (W&D-HRC & W&D-Sonapur). While the W&D-HRC is attached to the CFS, W&D-Sonapur is internally connected to CFS-Kolkata via rail / road. They currently provide the following services:


#### Visakhapatnam

Balmer Lawrie has partnered with Andhra Pradesh Medtech Zone (AMTZ) to provide the state-of-the-art Central Warehousing solution to its customers in Visakhapatnam. The AMTZ is the world's first Integrated Medical Device Manufacturing Hub.

The central warehouse is spread over an area of 3 acres (1,30,680 sq.ft.). All the manufacturing units that have their individual set up within the AMTZ premises can store their goods in the warehouse prior to distribution without having to rely on external assistance for this core service.

- 500 tons capacity pallet racking system
- 75,000 sq.ft. warehouse floor area with 9M minimum height
- 5,000 sq.ft. cold chamber (2-rooms at +4 deg C)
