- b) Payment of stamping fees and allied expenses.
- c) Supply of consumables such as Printer Head, Ribbons, Printing Stationery, software modification.
- d) Repairs of the working parts are included-except that for the structural members, lever work and load cells.
- 1. Please submit your rate item wise on your letter head duly signed and stamped in a sealed envelope super scribing Enquiry No. & Date on the top of the envelope.
- 2. <u>Contract period from 20/12/2018 to 19/12/2019</u> extendable for a further period of 1 year on mutual consent at the same rate, terms & condition.
- 3. Vendor should be responsible for all statutory obligations like PF / ESI Registration, Trade License, or any other obligations applicable for the above job.
- 4. Payment for AMC will be released in two part. 50% payment will be made immediate after completion of six month and balance 50% payment will be made after completion of the job. All other payment like stamping fees and related expenses will be released after submission of bill and completion of the job.
- 5. If any dispute or difference arises between the Parties inter alias in respect of the interpretation of this Agreement or of the rights or liabilities of either in respect of anything done or omitted or to be done or omitted hereunder, the Parties shall endeavor to settle such dispute amicably.
 - If not, such dispute or difference shall be referred for adjudication at Kolkata to a sole arbitrator to be appointed by C&MD, Balmer Lawrie & Co Ltd.
 - The place of Arbitration shall be Kolkata, India. The arbitration proceedings shall be in the English language. Cost of Arbitration shall be equally shared between the Parties. It is expected that the arbitral award shall be a speaking award setting out reasons thereof. In making the award, the arbitrator(s) shall be bound by the intention of the Parties insofar as the same can be ascertained from this Agreement.
- 6. Bids of any tenderer may be rejected if a conflict of interest between the bidder and the company is detected at any stage.
- 7. The vendor who is interested to participate in the tender should have their establishment in Kolkata or adjacent to Kolkata to ensure immediate support in case of break down, if any.
- 8. Contractors, vendors, who are having unresolved issues, disputes, complaint, legal or court cases against the company, will not be eligible to participate in the tender.
- Response from registered Vendors alone will be accepted and that other interested Vendors may seek to register with the unit and subject to such registration being confirmed, they would be considered for subsequent Tenders.
