3.0 <u>Delivery Terms</u>

Offer should be on door delivery basis [including Loading and unloading charges at either end] at our respective Units clearly specifying Basic Price,freight charges,material HSN code,GST percentage, company GST registration,packing size etc

4.0 <u>Delivery Schedule</u>

Material must be reach at our Silvassa plant with in 3 days from the date of placement of LOI/ PO.

5.0 Payment Terms

Payment will be released within 30 days from the date of delivery of material at our Respective units as stated above.

6.0 LD Clause

In the event the material is not received within the specified days mentioned above, a pre-determined liquidated damages will be applicable @ 0.5% per week subject to 5.0 % maximum of PO for the delivery portion in each lot.

7.0 <u>Validity</u>

Offer must be valid for our acceptance for a minimum period of 60 days from the due date of this tender.

8.0 Offer shall clearly indicate the following

- 1. Material is hazardous or not for users health?
- 2. Does product cause any kind of environmental pollution?
- 3. System to control air emissions, effluents and hazardous waste disposal system to comply with regulatory requirement?
- 4. Do any of your operations results in the creation of hazardous waste? If yes, is there a system in place to identify and properly dispose of hazardous waste?

9.0 Basis of selection

The on-line closed bids shall be used for grading the bidders .Location wise the lowest quoted bidder (Net Landed Rate) in the on-line closed bids shall be designated as "L1" and 100% order quantity shall be allocated to them for that location, subject to fulfilling of other tender clauses.

10.0 Submission of offer

The bidders are required to submit their offer on-line before the due date and time of the tender. However, EMD and other documents like technical literature etc. are to be submitted in a sealed envelope before opening of bid.

Provisions for Micro, Small and Medium Enterprises OR MSME

- a) Qualification Criterion: MSME vendor must confirm that UAN No has been uploaded on CPPP website as required by minister vide circular no F:No21(17) / 2016 dated 06.04.18 for qualifying to be considered as MSME vendor under this tender.
- b) Micro & small scale manufacturing units, registered under MSME/ NSIC, also complying clause of EMD: in the tender are exempted for submission of EMD amount.

Preference for Price Quotation in tenders: Participating Micro and Small Enterprises quoting price within price band of L1+15 per cent shall also be allowed to supply a portion of requirement by bringing down price to L1 price in a situation where L1 price is from someone other than a Micro and Small Enterprises. Such Micro and Small Enterprises shall be allowed to supply up to maximum 20 per cent of total tendered quantity for the grade at the respective plant subject to assessment of operational feasibility by tendering authority.

11.0 Conditions for online bid submission

Procedure for Bid Submission

The bidder shall submit his response through bid submission to the tender on eProcurement platform at https://balmerlawrie.eproc.in by following the procedure given below. The bidder would be required to register on the e-procurement market place at https://balmerlawrie.eproc.in and submit their bids online. No offline bids shall be entertained by the Tender Inviting Authority. The bidders shall submit their eligibility and qualification documents, Technical bid, Financial bid etc., in the standard formats prescribed in the Tender documents, displayed in eProcurement web site. The bidders shall upload the scanned copies of all the relevant certificates, documents etc., if required, in support of their eligibility criteria/technical bids in the eProcurement web site. However, bulky documents need not be scanned and uploaded but physical copy of the same should be sent to the Tender Inviting Authority office before the tender opening date. The bidder shall sign on the statements, documents, certificates, uploaded by him, owning responsibility for their correctness/authenticity.

Digital Certificate authentication
