Work covered in this tender document shall generally be as detailed herein below. - 2. The vendor has to impart training to Balmer Lawrie CFS personnel to configure and administer all the features of the Alarm system appliance along with documented manual.
- 3. The training is to be given at Balmer Lawrie premises.

GENERAL TERMS AND CONDITIONS

1. Eligibility Criteria
