TERMS AND CONDITION

1. The term **"Company (or) BL"** wherever mentioned in the tender document refers to **"BALMER LAWRIE & CO. LTD."**
2. The term **"bidder"** means the firm or company with whom the order is placed and shall be deemed to include the bidder, successors, representatives, heirs, executors and administrators duly approved by the company.
3. **Transit Risk Insurance:** Transit Risk Insurance shall be covered by the successful bidder.
4. **Delivery:** The successful bidder has to supply the equipment **within 45 days** from the receipt of the purchase order F.O.R Manali, Chennai-68.
5. The offer shall be submitted in our enquiry format only and any conditional offers will not be accepted.
6. The offer must be kept valid for a minimum period of **60 Days** from the date of opening the offer.
7. **Taxes & Duties:**
 - a. The price quoted by the successful bidder shall remain valid till expiry of Period of Contract. During the tenure of the contract period, no rate increase will be considered, except for change in statutory levies imposed by Union / State Govt. / Local authorities.
 - b. **Goods & Service Tax will be extra** and accordingly the bidders are required to provide GST Registration Number as sought in the Bid Form.
8. Payment: **30 days from the date of receipt of material at our Stores.**
9. **Warranty:** The successful bidder shall provide guarantee for a period of **12 months** from the date of supply. The successful bidder shall replace any part/component which has failed due to poor workmanship.
10. The bids of any bidder may be rejected if a conflict of interest between the bidder and the Company is detected at any stage.
11. **Cancellation of Tender:** In the event of unsatisfactory performance of developments leading to creation of lack of confidence in the successful bidder at any stage of operation of the contract, the Company reserves the right to cancel the contract. The company will be the sole judge in taking such a decision and will not be obliged to assign any reasons for its action. Such cancellation will be without prejudice and entirely at Company's discretion.
12. **BLCL reserves the right to relax any of the tender conditions, if necessary, while finalizing the tender at its discretion.**
13. **Penalty Clause:** Any failure on the part of the vendor to supply the material as per the delivery schedule, required quantity, approved quality etc. will be viewed seriously. Further, the company reserves the right to procure the material from the local market at the then prevailing price and the additional cost if any incurred in this process will be recovered from the vendor. Also the vendor may be debarred from participating in future tenders of the company.
14. Late tenders / delayed tenders including postal delay and those not conforming to the prescribed terms and conditions will not be considered.
15. The bidders are required to read all the above terms and conditions and sign the pages as acceptance of the same while quoting the price.
16. The company would not carry out any negotiations except with such bidders who is / are the lowest quoted bidders originally. As such it would be in the interest of the bidders to quote the lowest possible rate.
17. It shall be understood that every endeavor has been made to avoid error which may materially affect the basis of the tender and the successful bidder will take upon himself to provide for risk of any error which may subsequently be discovered and shall make no subsequent claim on account thereof.
18. **ARBITRATION:-** Any dispute or difference arising under this Contract shall be referred under jurisdiction of Chennai to a sole arbitrator to be appointed by the Chairman & Managing Director, Balmer Lawrie & Co. Limited and the provisions of Arbitration and Conciliation Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings. The fees of the arbitrator, if any, shall be shared equally by both the parties. The award shall be a speaking award stating reason therefor and is final and binding on the parties. The proceeding shall be conducted in English language and courts at Chennai will have exclusive jurisdiction to settle any dispute arising out of this contract.
