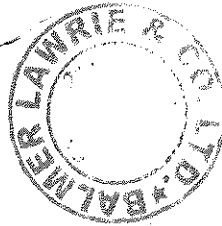

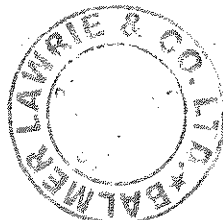

Annexure-B

- 2.1 **Submission of offer:** - Bidder shall submit their sealed offer in TWO bids in a single envelope, superscripting the envelope with tender No., date & due date along with following enclosures-
- [i] Covering letter:- Along with two sealed envelopes in an main envelop.
 - [ii] Annexure-A (Tech. data sheet duly filled ,signed and stamped in a separate sealed as envelop- mentioning Unprice Bid/Technical bid on the top of envelop-I)
 - [iii] Annexure-C (Price schedule - duly filled in a separate sealed envelop-II as Price Bid).
- Both sealed envelopes [I & II] will be put inside the main envelop [Duly sealed] along with covering letter should reach us on or before due date.
- 2.2 **Acceptance of Offer & Placement of PO:** -Balmer Lawrie & Co. Ltd. (BL) reserves the right to reject/accept all or any tender(s) without assigning any reason whatsoever. A tenderer must have to quote for all the items/heads under supply for this tender. Purchase order will be placed on a single **technically & commercially qualified bidder**, whose total price of subject supply **stands lowest, hence technically disqualified offers are likely to be rejected.**
- 2.3 **Delivery/completion schedule:** - The expected delivery & installation/commission period for the subject items within 8-10 weeks from the date of Purchase Order (PO) or LOI which ever is earlier. However, the short/early completion period quoted by bidder for the job(s) may be preferred. The delivery shall be made to our works at **Survey No. 201/1, Sayli, Sayli-Rakholi Road, Silvassa – 396230(UT of D&NH).**
- 2.4 **Jurisdiction:** - All disputes are subject to Silvassa jurisdiction.
- 2.5 **Liquidated Damages:-**In case of failure to deliver the item (of acceptable quality) by the successful vendor, as per the delivery schedule, reduction in PO value @ 0.5% per week subject to a maximum of 5.0% shall be applicable.
- 2.6 **After sales service:** - Bidder shall furnish the contact details of after sales service facility available at OR around Silvassa and has to submit a declaration for the availability of all 'Spare/assembly parts' of the supplied pump(s) for at least next five years; if required by BL in future for replacement against normal wear –n-tear(preferably with their respective prices).
- 2.7 **Price schedule:** - The price shall be quoted as per specified format given in Annexure –B. Do not leave any space blank or incomplete, write NA/NIL/Free in such case. Each page of the offer (enclosures) has to be acknowledged by the bidder with their acceptance (signature & company stamp). In case of offer, which are not found in line with our guidelines and Terms & Conditions, may subject to rejection. If the tenderer find any discrepancy, omission, ambiguity or conflict in or among the documents forwarded or be in doubt as to their meaning and interpretations, such matter shall be brought to the attention of the BL (Balmer Lawrie & Co. Ltd.), at least four days before/prior to the date of filling/submission of the Tender.
- 2.8 **Payment terms:** - (i) 95% on 30 days credit after supply from the date of submission of related documents(ii) Balance 5 % of PO Value shall be kept as retention money & will be released after completion of guarantee period without any interest or against submission of Performance Bank Guarantee(on BL format) for equal amount.
- 2.9 **Performance Bank Guarantee (PBG):** - PBG shall be furnished in specified format of BL and shall be valid for the related guarantee period from the date of successful commissioning/supply of the supplied items.

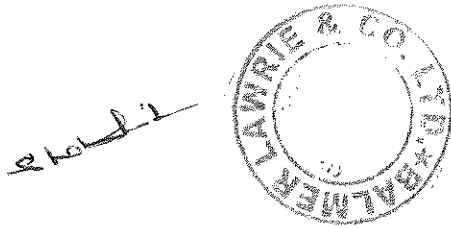

- 2.10 **Guarantee/warranty Period:** - 12 (Twelve) months from the date of successful commissioning/supply or 18 months from the date of supply of each unit whichever is earlier. During this guarantee period the performance of the supplied item has to be in line with the expected / agreed quality as per tender/PO and if not then vendor has to replace/rectify the same at **no extra cost to BL** and to the satisfaction of BL/tender.
