Please arrange to send your most competitive sealed offer [fax/e-mail offers are not acceptable] for supply of **300 Kg (+/- 10%) of oil soluble RedDye Liquid at our Kolkata plant.**

Your offer should be on **door delivery** basis [including Loading and unloading charges at either end] to our Kolkata plant clearly specifying Basic Price,freight charges, delivery period, packing size, GST percentage, material HSN code , Company GST registration if any, etc.

Delivery Schedule: Within 15 days to reach our Kolkata factory (P 43 Hide Road Extension Kolkata - 700088) from the date of Purchase Order/LOI. The contract should be valid up to 30.06.2018.

Validity Period: Offer validity shall 30 days from due date.

Payment terms: 30 days from date of receipt of material.

Offer shall clearly indicate the following:

- (a) Material is hazardous or not for users health?
- (b) Does product cause any kind of environmental pollution?
- (c) System to control air emissions, effluents and hazardous waste disposal system to comply with regulatory requirement?
- (d) Do any of your operations results in the creation of hazardous waste? If yes, is there a system in place to identify and properly dispose of hazardous waste?

Provisions for Micro , Small and Medium Enterprises (MSME) :

- a) Qualification Criterion : MSME vendor must confirm that UAN No has been uploaded on CPPP website as required by minister vide circular no F.No21(17) / 2016 dated 06.04.18 for qualifying to be considered as MSME vendor under this tender.
- b) Micro & small scale manufacturing units, registered under MSME/ NSIC, also complying clause no : 22.a in the tender are exempted for submission of EMD amount.
- c) Preference for Price Quotation in tenders : Participating Micro and Small Enterprises quoting price within price band of L1+15 per cent shall also be allowed to supply a portion of requirement by bringing down price to L1 price in a situation where L1 price is from someone other than a Micro and Small Enterprises. Such Micro and Small Enterprises shall be allowed to supply up to maximum 25 per cent of total tendered quantity for the grade at the respective plant subject to assessment of operational feasibility by tendering authority.
