Online bids are invited for supply for supply of **16800 Liter** [40 barrels in Kolkata and 40 barrels in Silvassa , considering each barrel quantity 210 Liter] **[+/- 10%]** of **engine coolant Dilute in Barrel**. The bidder shall submit his response through bid submission to the tender on e-Procurement platform at <https://balmerlawrie.eproc.in> .

B. QUALITY & ACCEPTANCE OF THE MATERIAL

- a) The successful bidder must ensure the quality and no deviation from the enclosed specifications shall be entertained. The testing done at our QA Department & / or in external govt. certified laboratory arranged by the Company shall be final and binding on the supplier.
- b) The bidder must provide evidence of engine coolant manufactured by them to meet full requirements of JIS K 2234 – 94 with necessary certificate from “The Automotive Research Association of India” along with their offer.

C. Terms and conditions of contract

1 PERIOD OF CONTRACT

- Material shall be delivered preferably in single lot OR as indicated in call-ups.
- Supplies should commence within 15 days of placement of Call Ups.
- Cost of delivery shall include transportation, loading / unloading charges, if any. The bidders are advised to include these charges while quoting their price.

3 PRICE BASIS

- Bidder shall submit FOR, BL-Kolkata and Silvassa Plant price for supplies in 210 Ltr HMHDPE barrels. The basic price, freight charges, GST percentage, material HSN code are to be clearly specified in the offer.
- Your offer is to be based on RIL/IGL/IOCL **04st March' 19** published price / rolled over price of MEG. **The price will be remain firm during the contractual period.**

Basis Of selection:- L1 bidder will be selected location wise net landed cost (clearly specifying Basic Price, freight charge, GST percentage, material HSN code, Company GST registration No packing size etc).

4 LD CLAUSE

Timely delivery is the essence of the order. In case of delay in supplying the material at Balmer Lawrie's (BL) plant beyond the lead time mentioned in clause no: 2, a pre-determined reduction of price to sum equivalent to 0.5% of the basic order value of the delayed supplies per week or part thereof subject to a maximum of 5% of the basic order value will be applicable.

Further, BL, at their own option may go in for Risk Purchase for not delivering the material beyond 1 (one) month of the date of call up and in such instances Security Deposit will be forfeited.

5 PAYMENT TERMS

30 days from the date of receipt of the material at respective locations and acceptance of same after necessary quality checks by our Quality Assurance Department.



6 VALIDITY

The offer shall remain valid for a period of **30 days** from the due date of the tender.

7 EARNEST MONEY DEPOSIT (EMD)

All bidders must submit an interest free EMD of INR 5000 (rupees Five thousand only) by Pay Order / DD drawn on any schedule bank in India in favour of "BALMER LAWRIE & CO. LTD." and payable at Kolkata (Calcutta) or through online bank transfer in NEFT/ RTGS/IMPS mode., India. EMD of unsuccessful bidder(s) will be returned after finalization of the tender.

Provisions for Micro , Small and Medium Enterprises (MSME) :

- a) Qualification Criterion : MSME vendor must confirm that UAM No has been uploaded on CPPP website as required by Ministry's circular no F:No21(17) / 2016 dated 06.04.18 for qualifying to be considered as MSME vendor under this tender.
- b) Registered MSME vendors shall be exempted from need to furnish EMD, subject to their submission of registration details. Declaration of Udyog Aadhar Memorandum [UAM Number] number by the MSME vendors on Central Public Procurement Portal [CPPP] is mandatory to qualify for availing the benefits as per Public Procurement Policy for MSMEs.
- c) Preference for Price Quotation in tenders : Participating Micro and Small Enterprises quoting price within price band of L1+15%, will qualify to supply a portion of requirement by bringing down price to L1 price in a situation where L1 price is from someone other than a Micro and Small Enterprises. Such Micro and Small Enterprises shall be allowed to supply 25 per cent of total tendered quantity for the grade at the respective plants subject to operational viability as considered appropriate by tendering authority. It may be further noted that if more than one such duly qualified MSME bidder matches non-MSME L1 price, 25% of the tender quantity will be equally split between the L1 matching MSMEs. If more than one MSME bidder has quoted in afore-said price band, number of such bidders will be intimated by tenderer to MSME bidders when seeking their acceptance to match L1 bid."

CONDITIONS FOR ONLINE BID SUBMISSION

Procedure For Bid Submission

The bidder shall submit his response through bid submission to the tender on e-Procurement platform at <https://balmerlawrie.eproc.in> by following the procedure given below. The bidder would be required to register on the e-procurement market place at <https://balmerlawrie.eproc.in> and submit their bids online. No offline bids shall be entertained by the Tender Inviting Authority. The bidders shall submit their eligibility and qualification documents, Technical bid, Financial bid etc., in the standard formats prescribed in the Tender documents, displayed in eProcurement web site. The bidders shall upload the scanned copies of all the relevant certificates, documents etc., if required, in support of their eligibility criteria/technical bids in the eProcurement web site. However, bulky documents need not be scanned and uploaded but physical copy of the same should be sent to the Tender Inviting Authority office before the tender opening date. The bidder shall sign on the statements, documents, certificates, uploaded by him, owning responsibility for their correctness/authenticity.

- The Coolant should be certified and approved by ARAI Pune or any other NABL accredited national standard laboratory as per IS: 5759-2006 and JIS K 2234-2006 specification.

ANNEXURE II**A) SPECIFICATION OF 210 LTR CAPACITY HMHDPE BARRELS**

1. 210 Ltr capacity high molecular weight, high density polyethylene barrel of GREEN/BLUE color body of weight 8.2 kg minimum.
2. To pass following tests : a) Drop Test from a height of 1.2 meters
b) Hydraulic Pressure Test at 110 kPa
c) Air leak test at 35 kPa
3. Two closures of 50mm dia with internal thread and matching PP plugs and O-rings.
4. Silk screen printing of "BALMEROL" and "For Industrial Use" on body of barrel as per art-work given by BL
5. **Supplier should put their details on stickers only. No logo on top or body to be printed.**
