Parties are advised to check the job area physically before quoting the rates.

SCOPE OF WORK & RESPONSIBILITY

Work covered in this tender document is detailed herein below. However, Contractor shall be responsible to complete the work in all respects and in doing so provide/supply all facilities which may not be covered below but nevertheless are required to complete the work envisaged with the exception of only such items as have been specifically excluded from contractor's scope.

Successful tenderer shall have to undertake the following work:

Detailed Scope of work:

To undertake Periodical Services of Pest, Rodent and Allied Services at our Office Building and various other places at P-43, Hide Road Extn., Kolkata - 88, complying the following general norms outlined below:-

- a. Each operation shall include spraying, dusting and fumigating the premises, records, stationery, hall, etc. with modern pesticides like Deldrin, Radar, Malathion Cythion, Lenden, Chloropyrifos [Pyrial], etc. Standard material I chemicals marketed by recognized companies, such as NOCIL, BAYER, SEARLE INDIA LTD., etc. should be used in proportions suggested by Bureau of Indian Standards.
- b. The quality of the material to be used by the party for pest/ rodent control must be such that it does not in any way affect the health or well-being of the party's own persons who do the servicing/ spraying, BL employees, associates and other who are present in the services/ sprayed area. There should not be any adverse effect on the environment or the public at large also. All liabilities, if any, due to any eventuality would be with the party. BL would have no liabilities including regarding statutory matters in this regard.
- c. Supply of all material for the job and servicing of same, ensuring health and safety of all who are working at the establishment while the control/ spraying is done is the responsibility of the party. Company would have no liabilities in this regard.

- d. Spraying/ servicing to be done at times so that there is minimum human interference during such activity. This would be strictly as per permission from BL to be obtained. Work should be carried out on off -days/ late hours (without any additional expenditure) in office buildings etc.
- e. The Contractor should ensure that the person(s) deployed by him behave in an orderly manner and shall not create any nuisance inside the premises and adhere to the administrative rules of the company while working inside the factory premises.
- f. It is clearly understood that the person(s) engaged by the Contractor are his own workmen and not employees of the Company. The Contactor will be responsible to comply with the provisions of various labour legislations including all rules and regulations of different Labour Boards.
- g. The Contractor will have to submit a list of personnel(s) to the Company for issuance of entry pass. Only pass holders will be permitted to enter G&L, Kolkata premises. All persons engaged by the contractor should have necessary photo identity cards issued by the contractor.
- h. Completion of all jobs would need to be marked on the job-card and countersigned immediately by BL representative after completion of the job. Copy of such would be submitted with the bills.
- i. Company reserves the right to advise change of material in case the same is not found effective in control of the insects. This would be binding on party without any increase in rates. Company also reserves right to ask for repeat service at no extra cost if the procedure is not found to yield results.
- j. Ensure adherence to all safety norms.

The above list is illustrative and not exhaustive, and the contractor will arrange for necessary operations as and when required and as instructed by the Company officials.

GENERAL TERMS AND CONDITIONS:

1. Eligibility Criteria for Techno-Commercial Bid:

2. Provisions for Micro, Small and Medium Enterprises (MSME):

- a) Qualification Criterion: MSME vendor must confirm that UAM No has been uploaded on CPPP website as required by Ministry's circular no F: No.21 (17) / 2016 dated 06.04.18 for qualifying to be considered as MSME vendor under this tender.
- b) Micro & Small Manufacturing units, registered under MSME/NISC, are exempted for submission of EMD amount.
- c) Preference for Price Quotation in tenders: Participating Micro and Small Enterprises quoting price within price band of L1+15%, will qualify to supply a portion of requirement by bringing down price to L1 price in a situation where L1 price is from someone other than a Micro and Small Enterprises. Such Micro and Small Enterprises shall be allowed to supply 25 per cent of total tendered quantity for the grade at the respective plants subject to operational viability as considered appropriate by tendering authority. It may be further noted that if more than one such duly qualified MSE bidder matches non-MSE L1 price, 25% of the tender quantity will be equally split between the L1 matching MSEs. If more than one MSME bidder has quoted in afore-said price band, number of such bidders will be intimated by tenderer to MSE bidders when seeking their acceptance to match L1 bid."

3. RATE:

The rates should be quoted as per Price Bid format only which shall be including all Taxes & duties, transportation (if any).

4. PAYMENT:

Payment will be made within 30 [thirty days] from the date of submission of monthly bills after conducting the required services for preceding month.

5. VALIDITY OF OFFER:

Offer should be valid for 120 days for acceptance by BL from the due date of submission of the Tender. Rate quoted shall remain firm during the contract period and for extended period if mutually agreed upon.

6. CONTRACT PERIOD:

The period of contract should be for one year from the date of Work Order/LOI and on mutual consent may be further extended for another one year.

7. COMPLIANCES:

The services as and when required would be done by persons authorized with permit by the party for carrying out the servicing/ spraying job. Such persons

should be provided with all required safety equipments including suitable masks, gloves and have sufficient training/ instruction for the job by the vendor. All statutory and other obligations regarding such persons would be with the vendor. BL reserves the right to make statutory deductions from bills if required by the law of the land. It shall be responsibility of the contractor to ensure that he conforms to the various provisions of statutory Acts as detailed below wherever applicable in respect of contact labour to be engaged by him. He shall also indemnify the Company against all losses/claims in respect of injuries to any contract labour/workmen engaged by him or physical damage to any Company property whatsoever, arising out of the execution of the work/carrying out of the contract. The contractor shall also indemnify the Company against claims or losses arising on account of non compliance of statutory provisions or for any reason whatsoever in respect of the various Acts.

8. TERMINATION:

The contract may be terminated by either party by giving at least two months notice. In such case BL would be liable to pay the charges for services already rendered till such notice of termination is served only.

9. ACCEPTANCE OF OFFERS:

- a. Balmer Lawrie reserves the right to accept any tender in whole or in part or reject any tender or all tenders or place order for any quantity, less than or more than the tendered quantity, without assigning any reason thereof.
- b. Bids of any tenderer may be rejected if a conflict of interest is detected between the bidders and Balmer Lawrie at any stage.
- c. Balmer Lawrie also reserves the right to split the supply order between two or more agencies if necessary; such a step shall not form the basis for alteration of rates.
- d. Balmer Lawrie is not bound to accept the lowest rate for any tender. Balmer Lawrie also reserves its right to allow Public Enterprises (Central / State) price / purchase / contract / service preference as admissible under the existing Government policy. The decision of Balmer Lawrie in this connection will be final.
- e. Incomplete tenders, conditional tenders, tenders received late or tender not conforming to the terms and conditions mentioned in the Tender documents or not accompanied by the requisite Earnest Money Deposit (unless exempted under the terms

of this Tender) will be rejected.

10. SAFETY:

The bidders are strictly advised to follow all the safety aspects in attending to the said work. Under no circumstances Balmer Lawrie will be responsible for any kind of deviation in the safety instructions by the bidder.

11. SUB- LETTING OF WORK

No part of the contract or any share or interest therein shall in any manner or degree be transferred, assigned or sublet by the contractor directly or indirectly to any person, firm or corporation without the consent in writing from Balmer Lawrie. In the event of contractor contravening the conditions, Balmer Lawrie shall be entitled to get the work done from other firm at the 'Risk & Cost' of the contract.

12. FORCE MAJEURE CONDITIONS

Delivery schedule is subject to force majeure conditions as under: If at any time during the continuance of this contract, the performance in whole or part by either party of any obligation under this contract shall be prevented or delayed by reasons of any war, hostility, acts of public enemy, civil commotion sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lock outs or acts of God (hereinafter referred as 11events11) provided notice of the happening of any such events is given by either party to the other within twenty one days from the date of occurrence thereof, neither party shall by reasons of such event, be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such non performance or delay in performance and deliveries under the contract shall be resumed as soon as practicable.

13. ARBITRATION

Any dispute or difference ar1smg under this Contract shall be referred for adjudication at Kolkata to a Sole Arbitrator to be appointed by the Managing Director, Balmer Lawrie & Co. Ltd. and the provisions of Arbitration Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings. The fees of the Arbitrator, if any, shall be shared equally by both the parties.
