#### **TERMS AND CONDITIONS**

- 1. The term "Company (or) BLCL" wherever mentioned in the tender document refers to "Balmer Lawrie & Co. Ltd
- 2. The term "bidder" means the firm or company with whom the order is placed and shall be deemed to include the bidder, successors, representatives, heirs, executors and administrators duly approved by the company.
- 3. Purpose of the contract: This contract is for the sale of Old/Used/ wooden pallets which are received as packing materials along with the sheet bundles received in Barrel Plant.
- 4. Period of Disposal: Staggered for a period of Six Months from <u>June 2019 to November 2019</u> based on accumulation will be sold against intimation from company.
- 5. The quantity indicated is only an estimation however, the company reserves the right at its discretion to enhance the ordered quantity by another 15% during tenure of contract period to the successful bidder.
- 6. Quantity mentioned indicative and is subject to change depending upon accumulation.
- 7. The offer shall be submitted in our enquiry format only and any Conditional offers will not be accepted.
- 8. The RATE given in the offer should be expressed both in words and in figures and where there is difference between two, the RATE given in the words will be authentic.
- 9. The material can be inspected on any working days between 10.00AM and 4.00PM.
- 10. The offer must be kept valid for a minimum period of 90 Days from the date of opening the Offer.
- 11. The company would not carry out any negotiations except with such bidders who is / are the highest quoted bidders originally. As such it would be in the interest of the bidders to quote the highest possible RATE. During negotiation or in the revised offer, only upward revised RATE shall be valid for consideration.
- 12. The bidder will be required to confirm the negotiations in writing within the time stipulated. If the bidder fails to comply with this requirement, the company reserves the right to evaluate his tender at its discretion based on their original RATE.
- 13. The successful bidder shall purchase all Old/Used/wooden pallets in "AS IS WHEREIS BASIS" and "No Complaint basis". This may include accumulated and carried forward quantity from time to time during the tenure of the contract.

## "SEGREGATION / SELECTION OF ABOVE ITEMS WILL NOT BE PERMITTED"

- 14. At no given time shall the successful bidder be allowed to accumulate Old/Used/wooden pallets. However, at the end of the contract period, even the part truck load material available should be cleared. As such the bidder must ensure regular removal of above items from our factory and organize to keep our shop floor and the factory premises clean of the above items at all times.
- 15. <u>SECURITY DEPOSIT (SD)</u>: Within 15 days of the company's communication to the successful bidder on acceptance of RATE, the bidder will have to deposit with the company a sum equivalent to 10% of the value of the contract subject to a minimum of Rs.5,000/- (Rupees Five Thousand only) as SD by DD/Pay Order drawn in favour of Balmer Lawrie & Co. Ltd., payable at CHITTOOR [AP] and Cheque will not be accepted.
  - The Security Deposit will not bear any interest.
  - The successful bidder should deposit the Security Deposit amount separately. Security Deposit cannot be clubbed with any Running Account.

16. **PAYMENT:** All payments shall have to be made in advance by NEFT/Demand Draft drawn in favor of Balmer Lawrie & Co,. Ltd., payable at Chittoor, before removal of the Old/Used/wooden pallets. Payment should be submitted to our company at least one day in advance before lifting the material.

### 17. PENALTY CLAUSE:

- In case of unsatisfactory performance of the Bidder either in relation to lifting of the materials or to adherence of specified time limits or to misbehavior of the Bidder's employees with the companies / customer Old/Used/ wooden-pallets elsewhere, in which case the Bidder shall also be liable for forfeiture of the Security Deposit
- The rate quoted by the bidder shall remain valid till the end of contract period. No decrease in rate will be considered by us except for statutory levy. No change in the accepted RATE shall be permitted during the period of contract under any circumstances.
- 18. The successful Bidder shall be responsible for fulfilling all obligations in respect of PF, ESI, Laws and Injuries Act etc. For their labour force working in company's premises. Necessary contributions for their workmen shall be deposited by the successful Bidder. They shall also provide complete information and furnish all records to the company whenever asked for. In the event of any additional levies or penalties being imposed on this account to remit the same within the due dates under advice to the company. In all respects, Bidder will be responsible for employment, welfare, conduct etc. of his employees.
- 19. Necessary labour for collecting / removing / loading the Old/Used/wooden pallets from our plant shall be organized by the successful Bidder and such labour shall be required to confirm to the normal Shift working hours of our Barrel Division.
- 20. The Bidder shall hold the company harmless and indemnified from and against all claims, charges and costs for which the company may be held liable under the Workmen's Compensation Act 1923.
- 21. Employees Liability Act 1930 and amendments thereof and expenses which the company may be made to bear by them in respect of personnel injuries to the servants and employees of the company, arising out or occasion through the acts of commissions/omissions whether due to negligence or not of the Bidder or his agents or his employees in carrying out the job of the Bidder.
- 22. The Bidder shall hold the company harmless and indemnified from all claims, costs and charges for which the company may be held liable in respect of any loss of injury exchanged to any third party through servants/employees/agents. This indemnity shall be in addition to, and not in lieu of any indemnity towards the company may be entitled by law.
- 23. The bids of any bidder may be rejected if a conflict of interest between the bidder and the Company is detected at any stage.
- 24. Late tenders / delayed tenders including postal delay and those not conforming to the prescribed terms and conditions will not be considered at all.

The proceeding shall be conducted in English language and courts at Chennai will have exclusive jurisdiction to settle any dispute arising out of this contract.
