- 1. Deciding location for carrying out destruction activities (incineration) and obtain necessary permission /NOC from the Customs, Health Department, PESO, Port Health Office, Drug controller office, M.P.C.B and any other concerned authorities as per requirement.
- 2. Sample collection and Laboratory test, if required to justify the nature of cargo
- 3. Arrangement of Relevant Authorities involved in Destruction/Incineration Activity.
- 4. Furnishing all the necessary Compliances , Certificates etc. to justify the destruction/incineration of the cargo in Customs
- 5. Transport arrangement of Containers from CFS to destruction site/ Incineration site, emptying and return back to empty yard.
- 6. Customs Overtime and Sundries etc., if any.
- 7. Arrangement of transportation for Customs Officials involved in destruction/ Incineration work , if required.
- 8. Arrangement of Labour, safety aids, chemicals, medicines, necessary equipment, tools and tackles Etc. required for destruction/ Incineration activity.
- 9. Arrange for destruction/ Incineration of unclaimed cargo and obtain final Destruction Certificate along with signed copy of Punchnama from Customs/ Police /health or any other authorities as per statutory requirement.
- 10. Any other job incidental to carrying out the required destruction of the cargo.

#### 1. Eligibility Criteria For Techno-Commercial Bid

- c) The tenderer should have valid GST Registration number, copy of GST registration should be submitted.
- d) The tenderer should not be black listed by any PSU or Govt. Department. Self-declaration for the same is to be submitted by the tenderer on their company's letter head.

#### 2. Submission Of Bids

The bids should be submitted in single bid process

Technical / Commercial Bid [Unpriced] with Price bid

For Price Bid, only the rates are to be submitted as per given format.
