TERMS AND CONDITION

1. The term "Company (or) BL" wherever mentioned in the tender document refers to "BALMER LAWRIE & CO. LTD."
2. The term "bidder" means the firm or company with whom the order is placed and shall be deemed to include the bidder, successors, representatives, heirs, executors and administrators duly approved by the company.
3. **Period of Work:**
 - A. As it is main power supply, the system cannot be spared fully for repairing more than full one day. So contractor has to take over the job intermittently whichever is possible during no production time. Accordingly, job may be carried out in different days based upon the potential of job for 3 to 4 hours.
 - B. It is compulsory to work on Sundays and holidays to avoid production loss.
 - C. On placing of order, contractor has to complete the job within 10 days put together.
4. The offer shall be submitted in our enquiry format only and acceptance of any conditional offers purely depends on the discretion of the BL.
5. The offer must be kept valid for a minimum period of **60 Days** from the date of opening the offer.
6. The price quoted by the bidder shall remain valid till the work is completed. During the tenure of the work period, no price increase will be considered, except for change in statutory levies imposed by Union / State Govt. / Local authorities.
7. **Payment: Within 30 days from the date of work completion on satisfactory of the job.**
8. **Penalty Clause:** Any failure on the part of the vendor to supply the material as per the delivery schedule, required quantity, approved quality etc. will be viewed seriously and the vendor may be debarred from participating in future tenders of the company.
9. The bids of any bidder may be rejected if a conflict of interest between the bidder and the Company is detected at any stage.
10. Late tenders / delayed tenders including postal delay and those not conforming to the prescribed terms and conditions will not be considered at all.
11. The company would not carry out any negotiations except with such bidders who is / are the lowest quoted bidders originally. As such it would be in the interest of the bidders to quote the lowest possible rate.
12. Only Registered vendors are eligible to apply. Bids from non-registered vendors are liable to be rejected. Any non- registered vendor interested in supplying the material/service may register with the company and shall be eligible for participation from the next tender onwards.
13. It shall be understood that every endeavor has been made to avoid error which may materially affect the basis of the tender and the successful bidder will take upon himself to provide for risk of any error which may subsequently be discovered and shall make no subsequent claim on account thereof.
14. **ARBITRATION:-** Any dispute or difference arising under this Contract shall be referred under jurisdiction of Chennai to a sole arbitrator to be appointed by the Chairman & Managing Director, Balmer Lawrie & Co. Limited and the provisions of Arbitration and Conciliation Act, 1996 including any statutory modifications or enactment thereof shall apply to the Arbitration proceedings. The fees of the arbitrator, if any, shall be shared equally by both the parties. The award shall be a speaking award stating reason therefor and is final and binding on the parties. The proceeding shall be conducted in English language and courts at Chennai will have exclusive jurisdiction to settle any dispute arising out of this contract.
