1. **Introduction**

6. **Negotiations**

All Bidders are requested to **note that no negotiations will normally be conducted on post price-bid open except with the highest bidder. It will, therefore, be in the interest of the Bidders to quote the highest price at the initial stage.** During negotiation or in the revised offer, only upward revised prices shall be valid for consideration. No change in the accepted rates shall be permitted during the period of contract under any circumstances.

7. **Security Deposit**

9. **Terms of Payment**

Successful bidder shall submit 100% advance payment along with applicable taxes of the approved price in the form of Demand Draft in favour of "Balmer Lawrie & Co. Ltd." payable at Mumbai.

10. **Completion Period and Up Lifting of Material**

On receipt of payment along with applicable GST, the successful bidder will start lifting the material within ten (15) days from the date of placement of the Order.

The entire up-liftment shall be carried out at Mumbai, Andheri and Pune Office by employing sufficient labour, tools/tackles and vehicles by the tenderer at his cost. The upliftment shall be done on any working day i.e. MONDAY TO FRIDAY from 10.00 am to 4.00 pm.

11. Any additional conditions other than mentioned in this tender document which may accompany the quotation of the bidder will not be acceptable. The bidder is deemed to

15. The successful tenderer shall also ensure that the entire scrap quantity offered to them are completely lifted from our premises before 4.00 PM on the close of the last working day of the contract period of 30 days, request for extension in this respect shall not be entertained.

16. **General Safety and Security Regulation**

The entire up-liftment of material shall be carried out in the specified premises and necessary labour shall be organized by the successful tenderer. The labour shall be required to be conforming to the working hours between 10.00 am and 4.00 pm.

Proper safety and security rules and regulations shall have to be adhered to. The work shall be done on after obtaining authorized permission. The bidder shall allow only those workers who have the authorized permits to enter the said premise. All entry / exit for vehicle, equipment, men and material shall be arranged by the bidder without any extra cost. Please note that in case of accident of any workmen, the entire responsibility for such employee will be the contractor.

The tenderer shall provide adequate labour to keep the designated area clean after removal of the specified items. The tenderer shall hold the Company harmless and indemnified from and against all losses during dismantling, shifting and loading of the equipment.

17. In case of unsatisfactory performance of the contractor either in relation to lifting of the materials or to adherence of specified time limits or to misbehaviour of the contractor's employees with the companies / customer employees, etc. the Company reserves its right to cancel part or whole of the contract and sell the material elsewhere, in which case the Contractor shall also be liable for forfeiture of the EMD.
18. The contractor shall hold the Company harmless and indemnified from all claims and charges for which the Company may be held liable in respect of any loss of injury exchanged to any third party through servants / employees / agents. This indemnity shall be in addition to and not in lieu of any indemnity towards the Company may be entitled by law.
