- Your offer should be guoted on FOR, at our works Manali, Chennai 600 068 basis only.
- Your offer should clearly indicate basic price, GST & freight charges if any separately.
- The rate quoted by you shall be remain firm till complete execution of entire order quantity of our PO
 against this enquiry during the year as stated above. Further extension as per mutual agreement for
 another Six Months.
- Your offer should be kept valid for a minimum period of 60 days from the date of submission of your offer
- Our normal payment terms are 30 days from the date of acceptance of material.
- Provisions for Micro and Small Enterprises (MSE.):
 - (a) Qualification Criterion: MSE vendor must confirm that UAN No has been uploaded on CPPP website as required by minister vide circular no F:No21(17) / 2016 dated 06.04.18 for qualifying to be considered as MSE vendor under this tender.
 - (b) Preference for Price Quotation in tenders: Participating Micro and Small Enterprises quoting price within price band of L1+15 per cent shall also be allowed to supply a portion of requirement by bringing down price to L1 price in a situation where L1 price is from someone other than a Micro and Small Enterprises. Such Micro and Small Enterprises shall be allowed to supply up to maximum 25 per cent of total tendered quantity for the grade subject to assessment of operational feasibility by tendering authority.
- <u>RISK PURCHASE CLAUSE</u>: In the event of the successful tenderers failing to supply the materials in time we are free to get the materials from any other party and the differential amount will be recovered from the successful tenderer's running bills.
