**M/s Balmer Lawrie & Co. Ltd.** (BL) invite sealed offer from transporters registered with SBU: Refinery & Oil Field Services (ROFS) for Transportation of Equipment from Balmer Lawrie, Warehousing & Distribution Unit, Sonapur Road, Kolkata to Oil & Gas Corporation Ltd (ONGC), Uran, Maharashtra as per the following details and terms & conditions

## 1.0 Description of Work

# 2.0 Scope of Work / Responsibilities

- 2.1 Transportation of the above materials from starting point to destination at the addresses noted in page no.3.
- 2.2 The above materials shall be loaded at Balmer Lawrie, Sonapur Road, Kolkata. Loading shall be under the scope of Balmer Lawrie.
- 2.3 The transported materials shall be unloaded inside ONGC, Uran Plant. Unloading at ONGC Uran shall be under the scope of Balmer Lawrie. However, all incidental charges at unloading point shall have to be borne by the transporter.
- 2.4 Necessary co-ordination with all concerned for carrying out the material loading & unloading at respective locations shall be the responsibility of the transporter so that, the loading/unloading is carried out smoothly and without undue delay.

- 2.5 Transportation of material shall be carried out in a safe manner and module will have to be properly secured with the vehicle to the satisfaction of Balmer Lawrie's personnel so as to eliminate possibilities of any damage and overturning during transit.
- 2.6 The transport vehicle shall meet concerned RTO regulations and drivers shall have valid driving license and the type of vehicle to be engaged at the place of origin to be indicated in the offer.
- 2.7 The order will be placed on strict understanding that the transporter has indemnified Balmer Lawrie & Co. Ltd. against any government action on him or his vehicle or his driver while on our duty.
- 2.8 Our decision will be final in the event of any dispute.
- 2.9 The transporter must keep Balmer Lawrie & Co. Ltd. fully absolved from all legal responsibilities arising out of any accident, injury, death etc. to his staff / labourers involved in the operation.
- 2.10 Rate should be valid for acceptance for a period of 90 days from the due date. Rate quoted should be firm and no escalation, whatsoever, will be granted during such period.
- 2.11 No deviation from the tendered condition is acceptable.
- 2.12 A responsible person from and on behalf of the bidder should be present both at loading and unloading points to take care of payments and also to ensure that the materials are loaded/stacked/placed/unloaded properly and safely.
- 2.13 Driver of the vehicle shall keep the following documents under their possession all the time, while carrying out the road transportation job:
  - a) Registration Certificate (RC) book of the Vehicle.
  - b) Valid Fitness Certificate of the Vehicle
  - c) Valid Insurance Policy of the Vehicle
  - d) Driving License of the Driver
  - e) Valid Pollution Control Certificate of the Vehicle
  - f) Any Photo Identify of the Helper/Khalasi accompanying the drive
  - g) Vehicle must be attached with all safety fittings. Spark Arrestor with be fitted with the vehicle and driver should be in possession of original receipt and certificate duly approved by appropriate statutory authority.

The reason for delay & non-entry of vehicle inside ONGC Uran Plant in absence of above shall be attributable to the transporter.

2.14 No materials, other than those specified in our invoices, should be loaded on to the vehicle en-route.

- 2.14 Invoice and e-way bills (Part-I) will be issued at the time of loading of materials at Kolkata.
- 2.15 Detention charges shall be payable if the vehicle is detained by Balmer Lawrie and not attributable to the transporter after 2 (two) working days of reporting at respective locations. Detention charges beyond the specified days is prefixed at Rs.1000/day for the vehicle. Bidder must accept such prefixed amount with their offer and no additional amount would be entertained after placement of order & execution of order.

### 3.0 Goods & Services Tax (GST)

GST shall be extra as per statute and to be paid by Balmer Lawrie to the concerned authority.

#### 4.0 Incidental Charges

All charges from unloading and enroute shall be borne by the bidder. Balmer Lawrie's site personnel should not be requested to make any payment at the loading and unloading points.

#### 5.0 Payment Terms

Full payment will be released against submission of invoice along with receipted LR and Part – II of e-way bills after successful completion of work.

#### 6.0 Destination Address

# 9.0 <u>Completion Schedule</u>

The consignment must reach ONGC, Uran within 10(ten) days (excluding the date of loading & reaching) of leaving the place of origin. The bidder shall have to do all sorts of coordination and liaisoning etc., as applicable to achieve this time target. Penalty @ Rs5000.00 per day will be levied for delay in completion schedule.

#### 10.0 Placement of Vehicle

Placement of vehicle must be made within two (2) working days from the date of intimation after placement of order, failing which penalty @ Rs.5000.00 per day will be levied over and above the compensation due to delay in completion schedule as specified in Clause no. 9.0 above.

#### 11.0 Tender Submission

Offer should include a stamped and signed copy of the Tender Document as a token of acceptance of the terms and conditions herein.
