- 3. Period of Supply: Within 15 days from the date of receipt of our Purchase order.
- 4. Quantity mentioned indicative and is subject to change depending upon market conditions.
- 5. The offer shall be submitted in our enquiry format only and any conditional offers will not be accepted.
- 6. The offer must be kept valid for a minimum period of **60 Days from** the date of opening the offer.
- 7. The price quoted by the bidder shall remain valid till the supply is completed. During the tenure of the supply period, no price increase will be considered, except for change in statutory levies imposed by Union / State Govt. / Local authorities.
- 8. Payment: 15 days from the date of receipt of material at our Stores.
- 9. <u>Penalty Clause</u>: Any failure on the part of the vendor to supply the material as per the delivery schedule, required quantity, approved quality etc. will be viewed seriously.
