## <u>Terms & Conditions:</u>

- 1) Empty containers has to be deposited at liner nominated plot—with in free period after unloading the cargo from container at delivery place in sound conditation.
- 2) Charges incurred due to late deposit of container at empty yard, will be to the account of transporter.
- 3) 100% payment will be made within 30 days of submission of the bills along with the Delivery Challans and satisfactory completion of the job.
- 4) Contractor will be responsible for payments on account of fuel, running, repairs & maintenance, upkeep, insurance, safety, taxes or levy or any penalty for any reason in relation to the vehicle. Drivers of the transporter should hold valid driving licenses. Contractor will be solely responsible to comply with all local & central laws relating to running/ownership of such commercial vehicles and shall arrange inter-state permits in advance at his costs only.
