1. The tenderer means all parties/firms who respond against this tender notice and successful tenderer(s) mean party/parties, with whom the order is placed and shall be deemed to include the tenderer's successors, representatives, heirs, executors and administrators duly approved by the firm.

2. **Purpose of Contract:**

This contract is for Sale of Waste as per Annexure-I

- 3. The tenderer is expected to quote in accordance with the terms and conditions of the Company. Printed Standard conditions which may accompany the quotation of the tenderer will not be acceptable.
- 4. **Period of Contract** From July 2020 to September 2020 & extendable for further period of 3 month with mutual consent.

5. Tender Evaluation

The tender would be finalized on the basis of Highest price Offered on Individual Items mention in Annexure -III.

- 6. The company reserves the right to accept any tender in whole or in part and reject any or all tenders.
- **7. Validity of Quotation**: The quotation should be valid for the Company's acceptance for a **period of 30 days** (excluding the due date) from the date of opening of the tender.
- **8. Sub-Contracting**: The successful bidder shall not be allowed to sub contract either wholly or any part of the order without Company's prior written consent.

9. PAYMENT TERMS

All payments shall have to be made in advance by NEFT/Demand Draft drawn in favor of "Balmer Lawrie & Co Ltd" payable at Mumbai before removal of material. Payment should be submitted to our company at least one day in advance before lifting of material.

- 10. **Security Deposit (SD)**: Within 15 days of the company's communication to the successful bidder on acceptance of the rate the bidder will have to deposit with the company a sum equivalent to 10% of value of the contract subject to a minimum of Rs.5000/- (Rupees Five Thousand Only) as SD by NEFT/DD/pay order drawn in favor of Balmer Lawrie & Co Ltd Payable at Mumbai and cheque will not be acceptable.
 - a. The security deposit will not bear any interest.
 - b. The successful bidder should deposit the security deposit amount separately. Security deposit can not be clubbed with any running account.

It is expected that the arbitral award shall be a speaking award setting out reasons thereof. In making the award, the arbitrator(s) shall be bound by the intention of the Parties insofar as the same can be ascertained from this Agreement.

In event of any dispute or difference relating to the interpretation and application of the provision of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts inter se and also between CPSEs and Government Departments/Organizations (excluding disputes concerning Railways, Income Tax, Customs & Excise Departments), such disputes or difference shall be taken up by either party for resolution through AMRCD as mentioned in DPE OM no 4(1)/2013-DPE(GM)/FTS-1835 dated 22.05.2018.
